Welcome to our **EU-funded TRANSITION (ID: 101101261) Training Program** designed to enhance the digital competencies of clinical and non-clinical professionals in the healthcare sector. Our goal is to equip professionals with the skills and knowledge necessary to leverage existing digital technologies effectively and embrace new ones, ultimately leading to more efficient, cost-effective, and patient-centered healthcare models.

The programme is primarily delivered **online in a MOODLE platform**, allowing participants to engage in virtual learning activities from anywhere. In addition, participants will have the opportunity to attend on-site workshops at selected locations.



The course platform will be accessible from **September 2024 to September 2025** for clinical and non-clinical modules.



Our training methods include interactive presentations, engaging lectures, case studies, and informative videos to cater to diverse learning styles and ensure maximum retention of knowledge.



Each program section is followed by **self-assessment** questions and a final quiz covering all sections will be administered at the end of the program.



The program is offered **free** of charge to all participants. This includes access to all program materials, virtual learning platform, and **certification** upon successful completion.

FREQUENTLY ASKED QUESTIONS (FAQS)

What qualifications or experience do I need?

We welcome applicants with the following professional backgrounds: oncology nurses, general medicine practitioners, radiation oncologists, surgical oncologists, medical oncologists, and health managers, aligning with the various areas covered in the training program. While prior experience in the field of training is preferred, we also encourage individuals with limited experience who possess the qualifications mentioned above to apply for participation in the program.

What topics and skills will be covered during the training sessions?

How long is the training program, and what is the time commitment required?

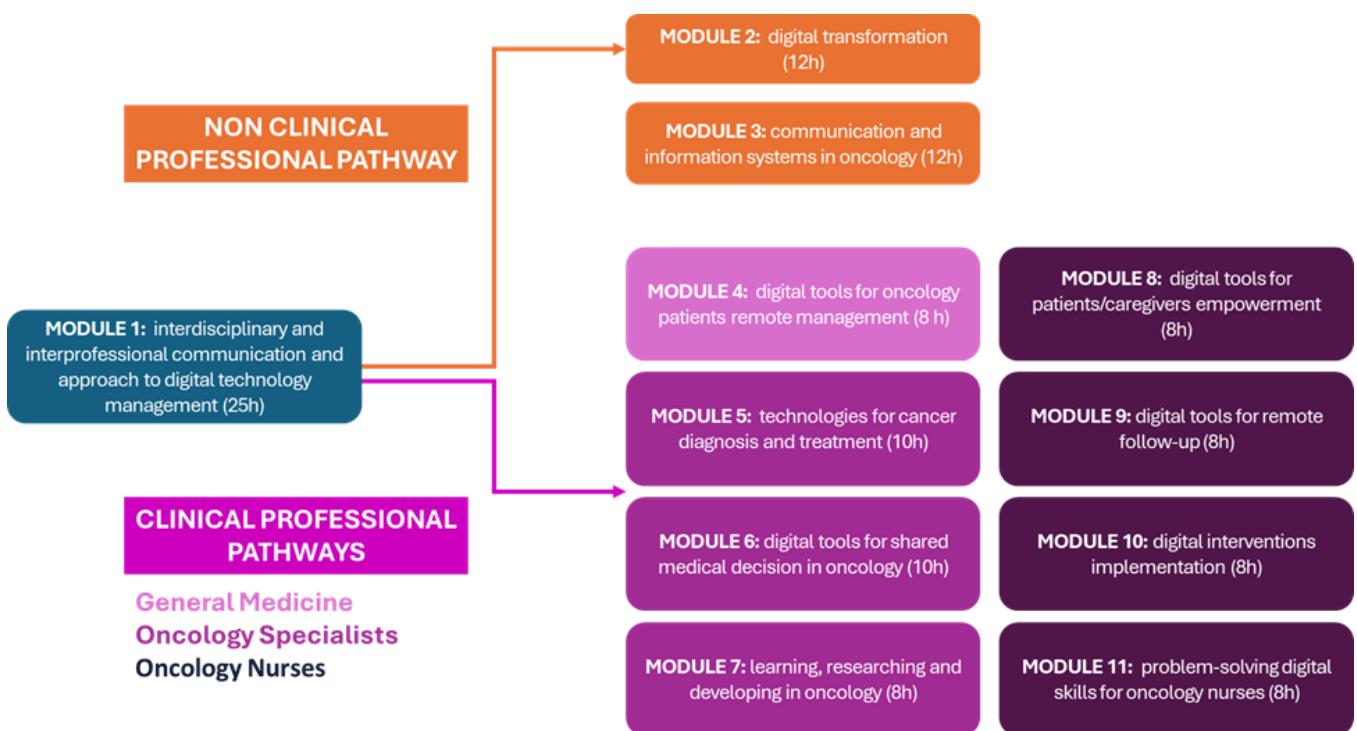


Figure 1 Learning pathways TRANSITION training programme

Firstly, there's a joint module, designed for both healthcare professionals and non-clinical professionals, which focuses on leadership in digital innovation and transformation and lasts 25 hours. This is followed by eight specialised modules tailored to the unique profiles of participants, each with a different duration, as shown in Figure 1. The comprehensive general medicine pathway covers 33 hours, while the oncology specialist pathway covers 53 hours and the oncology nurse pathway covers 57 hours. In addition, two modules are dedicated to health systems management and health authorities, focusing on strategic planning, organisation and monitoring of cancer care efficiency indicators. The full pathway for non-clinical professionals is 37 hours. All modules will be available between September 2024 and September 2025.

Participants are expected to complete the entire training programme, including the completion of self-assessment questions. They will also be required to complete a final quiz covering all sections at the end of the programme..

Will I receive a certification upon completion of the program?

The course is accredited by ACOE (Accreditation Council of Oncology in Europe) and offers micro-credentials. Participants can earn CMEs (Continuing Medical Education) or CNEs (Continuing Nursing Education) depending on their pathway: 33 CMEs for General Practitioners, 49 CMEs for non-clinicals, 53 CMEs for Oncology Specialists, and 57 CNEs (accredited by EUAB-CNE) for nursing professionals.

How will the training sessions be conducted? Are they in-person, online, or a combination of both?

The program will be delivered online via an external Moodle platform, with optional in-person sessions. Our training methods include interactive presentations, lectures, case studies, and informative videos. Each program section is followed by self-assessment questions.

Are there instructors and facilitators leading the training sessions?

The course is taught online with self-learning resources. Both the module materials and the assessment activities are designed so that you can progress at your own pace and check your progress, learning autonomously. While you are taking the course you will have the support of an expert tutor to resolve any doubts and queries you may have.
